The following table shows the list of the referential materials and documents which the drafting committee for the “*Civil and Commercial Code for the Kingdom of Siam*” had apparently consulted at its codification work. It contains mainly articles from “*Civil and Commercial Code for the Kingdom of Siam of 1923*” which is called “*Old Text*” in the table, “*Japanese Civil Code of 1896 - 98*”, and “*German Civil Code of 1898*”. The source of the table which I used in this study is;

The primary intention of my comparative study consists in a survey about the intensity of the influences by the German and Japanese civil codes upon the Civil and Commercial Code of Thailand. For my study, of course, this table is essential information. However, I firstly translated the original version of the Thai code into Japanese without referring to the Phraya Man's Index. I decided to do so in order to prevent any prejudice. At the translation work, I referred mainly to the Japanese, German and Swiss codes. As a byproduct of the translation, I tried to compose a provisional comparison table between Thai and those foreign codes which shows similarity or even identity between respective articles of those codes from my own sight. Afterwards, I compared my comparison table to the Phraya Man's Index. At the end, I took also the “*Old Text*” of 1923 into the scope of comparison.

About my supplementary entries to the Phraya Man's Index

Through my translating and comparative work, I came to an unexpected conclusion that the Phraya Man's Index would be somewhat incomplete. It does not mention to certain articles in those foreign codes at all which apparently relate to Thai articles in my sight. Even in the “*Old Text*”, I could identify much more closely related articles than those actually mentioned in the Phraya Man's Index. Indeed, this referential table was formed under the supervision of Sir *Phraya Manavarachasevee* (พระยามานวราชเสวี), the central figure in the drafting committee at that time. However, it is quite doubtful that he was just the person who really prepared the Index.² It would be probable that he could not have any opportunity to confirm the exactness and complicity of the Index by himself.

In any case, I decided to add some supplementary entries to the Phraya Man's Index according to my comparison table and integrated them into a single one. Moreover, it was important for my purpose to focus on a main source for each Thai article among several related ones while the Phraya Man's Index simply lists them in parallel without any differentiation of importance. So, I tried to specify a single, decisive source for each Thai article and to indicate it in the integrated new Index if possible. However, such an attempt can not be accomplished because some several sources often show almost same contents. Its objectivity may be also doubtful. In this sense, my decision of one main, decisive source for each article should be treated merely as a possible proposal, but not any proved truth.

It should be noticed also that I have refrained to treat sources in French language in this comparative study due to my limited language skill. I hope some motivated and competent researchers would join to discuss the relationship between Thai articles and other foreign sources in Roman languages.
